### **Abstrak**

Kabupaten Anambas merupakan salah satu wilayah yang mengandalkan sector perikanan, hampir sebagaimana besar mata pencarian disana adalah sumber daya penangkapan ikan. Wilayah Anambas merupakan wilayah yang menjadi focus penelitian karena adanya isu mengenai penangkapan ikan yang tidak sesuai prosedur yang di terapkan dan tidak sesuai aturan. CCRF (*Code of Conduct for Responsible Fisheries* ) merupakan Aturan dan prosedur etik ini akan menjadi standar dan dasar internasional untuk praktik atau perilaku penangkapan ikan yang bertanggung jawab dalam penggunaan sumber daya ikan untuk memastikan penerapan aspek perlindungan, pengelolaan, dan pengembangan sumber daya hayati perairan yang efektif. Dalam penelitian ini, peneliti menggunakan metode kualitatif. Penelitian ini juga mengadopsi pendekatan deskriptif berupa kata-kata dan data bukan berdasarkan perhitungan persentase rata-rata dan perhitungan statistik lainnya. Dalam penelitian ini bertujuan untuk mengungkap berbagai gambaran dan permasalahan terkait penerapan rezim CCRF (*Code of Conduct for Responsible Fisheries* ) terhadap penangkapan ikan yang merusak di perairan Kabupaten Kepulauan Anambas. Berdasarkan hasil penelitian maka dapat diambil kesimpulan bahwa penerapan Rezim CCRF(*Code of Conduct for Responsible Fisheries* ) terhadap destructive fishing di perairan Kabupaten Kepulauan Anambas dalam konsep Rezim Internasional belum efektif. Pemerintah mendorong pembenahan tata kelola perikanan. Masih banyak penangkapan ikan yang tidak tercatat. Maka tidak akan terdeteksi penangkapan yang berlebihan, Pemanfaatan sumberdaya yang dilakukan harus seimbang dengan pengelolaan sumber daya laut, agar sumber daya laut tidak habis.

**Abstract**

*Anambas Regency is one of the areas that relies on the fisheries sector, most of the livelihoods there are fishing resources. The Anambas area is an area that is the focus of research because of the issue of fishing that is not in accordance with the procedures applied and is not in accordance with the rules. CCRF (Code of Conduct for Responsible Fisheries ) is an ethical rule and procedure that will become an international standard and basis for responsible fishing practices or behavior in the use of fish resources to ensure the implementation of aspects of protection, management and development of aquatic biological resources that are effective. In this study, researchers used qualitative methods. This study also adopts a descriptive approach in the form of words and data, not based on average percentage calculations and other statistical calculations. This study aims to reveal various descriptions and problems related to the implementation of the CCRF (Code of Conduct for Responsible Fisheries ) regime for destructive fishing in the waters of Anambas Islands Regency. Based on the research results, it can be concluded that the application of the CCRF Regime (Code of Conduct for Responsible Fisheries ) towards destructive fishing in the waters of Anambas Islands Regency in the concept of the International Regime has not been effective. The government is pushing for improvements in fisheries governance. There are still many unrecorded fishing. Then overfishing will not be detected. The use of resources must be balanced with the management of marine resources, so that marine resources do not run out.*
